- The Passport has become a staple at New Resident Mixers, demonstrating its effectiveness in educating residents about town services.





Phase 1-3 Project Fee	\$62,900
Reimbursable Expenses	\$3,600
Total	\$66,500

Project Schedule: Approximately Four Months

Proposal Details from Olsson Studios

Phase 4 – Construction Documents –

- Deliverables:
 - Demolition Plan
 - Hardscape Plan
 - Construction Documents including elevations, structural engineering, lighting, and specifications for selected monuments

Phase 4 Project Fee: \$47,000 - \$68,000, under separate agreement

Next Steps:

- ✓ DTAC Recommendation on Olsson Studios Proposal, Phases 1-3
- Town Council approval of Agreement
- Schedule Kickoff Meeting with Staff
- Schedule Design Charette with DTAC, Preferably 3 consecutive days
