GENERAL INFORMATION FOR ALARM USERS

A permit must be obtained within sixty (60) days of the installation of an alarm system to transmit or relay a signal intended to summon emergency services of the Town of Prosper. Permits must be obtained before an alarm system is activated. It is the responsibility of the permit holder to apply for a renewal prior to the last day of the month in which the permit expires.

PERMIT FEES

Residential: \$50.00 Business: \$100.00

An annual, nonrefundable fee of \$50.00 is required for each permit or renewal of a permit for a private residence. The permit is valid for a period of 12 months from the date of issuance.

An annual, nonrefundable fee \$100.00 is required for each permit or renewal of a permit for a place of business. The permit is valid for a period of 12 months from the date of issuance.

More than 3 but fewer than 6 False Burglar Alarms Within 12 Months	\$50.00 per False Alarm
More than 5 but fewer than 8 False Burglar Alarms Within 12 Months	\$75.00 per False Alarm
8 or more False Burglar Alarms Within 12 Months	\$100.00 per False Alarm
More than 3 but fewer than 8 False Robbery/Panic/Duress Alarm Within 12 Months	\$75.00 per False Alarm
8 or more False Robbery/Panic/Duress Alarm Within 12 Months	\$100.00 per False Alarm

RESPONSIBILITY OF THE PERMIT HOLDER

The person in control of the local alarm shall comply with all requirements of operation and maintenance as outlined in the Town ordinance. The permit holder is responsible for informing the Town of any change that alters the information listed on the permit application.

All information regarding the Town ordinance for Alarm Systems can be found in Article 4.05 the Town's Code of Ordinances and Section XVI of Appendix A (Fee Schedule) of the Code of Ordinances.
