## Prosper Residents Invited to Participate in Parks, Recreation and Open Space Master Plan Process

### Resident Survey Open Through May 19

PROSPER, TX – April 17, 2024 – The Town of Prosper is excited to announce that planning is underway for the 2024 [Parks, Recreation and Open Space Master Plan](#)! This comprehensive blueprint, slated to be finalized in December 2024, will chart the course for the evolution of Prosper's park system. It will encompass recommendations for land acquisition, park expansion, development and tailored programming and activities for all ages. Additionally, it will explore the feasibility of a future multi-generational facility to accommodate Prosper's rapidly growing population.

Community input is vital to this process! The [Resident Survey](#) is now open to all Prosper residents, providing a platform to share ideas and preferences in shaping the future of our parks and recreation. Dan Baker, Director of Parks and Recreation, emphasized the significance of community feedback in this process: "The feedback we receive from survey responses is the most important element of this Master Plan update process. Town staff need to know what types of park and recreation facilities Prosper's residents want for their future. The more information we get from residents, the better we can plan our future funding and development strategies."

The Town has commissioned the expertise of Dunaway Associates to prepare this Master Plan. This collaborative process will engage residents, Town staff, a specially appointed Advisory Committee, the Prosper Parks and Recreation Board and the Prosper Town Council. The 2024 Parks, Recreation and Open Space Master Plan represents a significant update to the Town's original Parks Master Plan created in 2015.

We extend our gratitude to all Prosper residents for their involvement in the Master Plan 2024 process. Your input will serve as the cornerstone for the strategic framework guiding the development, maintenance, and management of parks, recreation and open spaces in Prosper for years to come.

**ABOUT THE TOWN OF PROSPER** – The Town of Prosper sits on 27 square miles and is home to approximately 38,000 residents with a projected build-out population of 72,000. Prosper is located where the northern edge of Dallas' Golden Corridor meets the U.S. 380 Corridor.
