Customers who are not billed in December, January and February will not have a winter average. Therefore, those customers shall be billed according to water consumed each billing cycle capping at 10,000 gallons until a winter average is established or service is terminated.

Senior citizen account holders who qualify are entitled to receive the first two thousand (2,000) gallons included as part of the minimum bill for indoor residential accounts. To be eligible, the customer must be the listed account holder age sixty-five (65) or older, complete an application for the discount, provide proof of age on a valid United States or State ID and not be receiving the senior citizen discount on any other Town of Prosper account.

Late payment penalties shall be waived for any account holder who qualifies and is entitled to such. An applicant must complete an application and present adequate proof that the customer is either: at least age sixty-five (65) **and** the recipient of social security or other bona fide retirement benefits, **or** totally disabled.

Multifamily Dwellings, Townhomes and other Multitenant Accounts served by one master meter will be billed a minimum water charge per unit equal to the  $\frac{3}{4}$ " residential base rate and the minimum service charge for wastewater. The residential volumetric charges will apply as \$7.92 at all volumes, except that winter averaging will not be applied to Multifamily Dwellings served by one master meter.

If the amount due on the 10th day of the month after the billing cycle is not paid in full, a ten percent (10%) penalty of the most current balance shall be added to the account.
